SYSTEM SECURITY DESIGN

The KPrinter System has different levels of access privileges for user groups. There are currently two main user groups, the Operators and the System administrators.

The System Administrator configures the system settings and creates login parameters for approved system users whereas operators are responsible for the daily use of the system.

KPrinter PDF Messages are stored on a central location. If the institution uses windows 2000/2003 domain architecture, KPrinter users will need to be assigned enough access rights to access these PDF documents.

STP, SPOOLER & AML ADD-ONS

The National Payment Systems require that SWIFT messages should be handled using Straight Through Payment systems so that beneficiaries are able to receive credit in real time. The STP module of KPrinter is designed to do this intelligently, irrespective of the Banking System used by you.

The Spooler is a facility of automatic printing by Message Type, Traffic Type to specific printers

The powerful Money-Laundering check built into KPrinter can alert the Bank if any banned entity has used or attempted to use your bank for laundering ill-gotten proceeds. The system alerts the Compliance Officer online and also enables him to process (allow or block) movement of money (above set limits or associated with banned entities) before it is too late. The system is capable of having your own blacklist of suspected persons if you wish so.

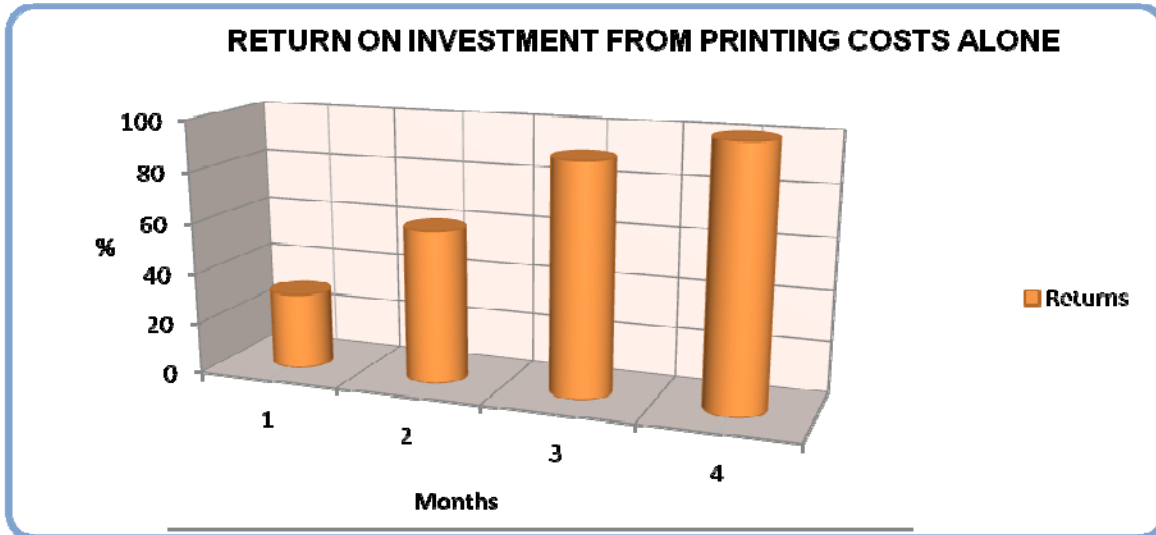
Another optional add-on, this may be used for storing other important documents in soft-form to be retrieved or moved around within the bank, quickly and conveniently.
